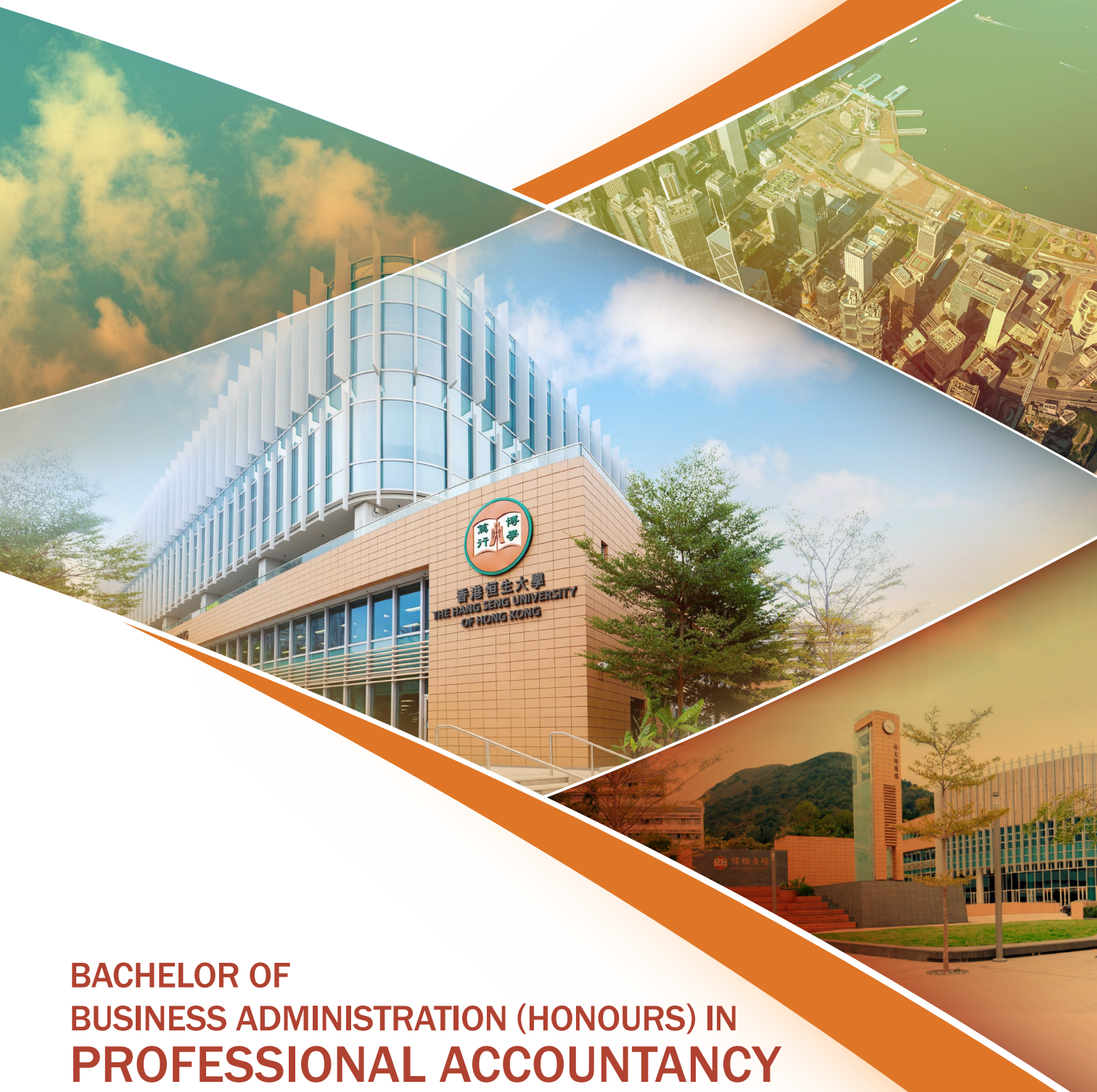

PROGRAMME OVERVIEW

課程概覽

The BBA (Hons) in Professional Accountancy equips students with both theoretical knowledge and practical skills for success in today's dynamic accounting profession. The programme offers academic flexibility and adaptability across diverse study modes, while integrating critical emerging fields into the curriculum.

Our comprehensive curriculum covers financial reporting, management accounting, auditing, taxation, law, financial management, ethics, contemporary computer technology, and accounting information systems. In addition, we offer a wide range of specialty electives in areas such as data analytics, ESG reporting, internal auditing, and corporate governance. Most of our faculty are qualified accountants with practical industry experience, and our graduates receive exemptions from various professional examinations.

Apart from academic study, students also benefit from mentorship, local and overseas internships, alumni networking, and coaching for professional competitions—building confidence and practical expertise. Our graduates are highly sought after by employers, securing roles in accounting firms, financial institutions, management trainee programmes, or pursuing further studies.

本課程兼具會計理論和實務知識，旨在為學生從事會計專業作好準備，以應對瞬息萬變的會計專業環境。課程設計具備高度彈性，提供多元修讀模式，並融入關鍵新興範疇。課程內容全面，涵蓋財務匯報、管理會計、審計、稅務、法律、財務管理、職業道德、當代電腦科技及會計資訊系統等核心範疇。同時亦提供多元化的專修選修科目，包括數據分析、環境、社會及管治（ESG）匯報、內部審計及企業管治。大部分授課教師為具有實務經驗的專業會計師。畢業生參加本地及國際專業會計團體專業資格考試可獲得豁免。我們積極鼓勵學生參加師友計劃、本地及海外實習、校友交流活動以及各項專業比賽。學生透過具特色且多元的學習體驗，進一步提升自信心與實務能力。畢業生的發展機會良多，深受僱主肯定。大部分畢業生就職於會計師事務所及金融機構，參加管理培訓生計劃，或在研究院繼續深造。

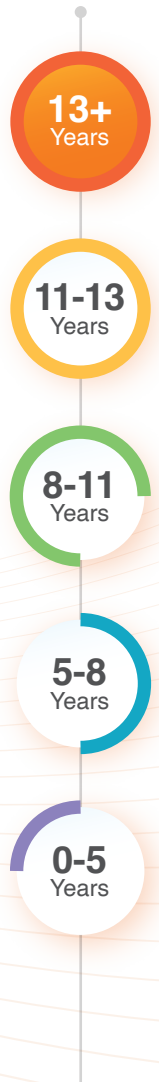

Furthermore, students can participate in the HSUHK Global Internship programme with internship locations covering 25 cities in 18 countries, including Australia, Germany, Ireland, Japan, New Zealand, Singapore, the UK and the USA. Students will work as interns in public organisations and multinational corporations such as Bank of China (Sydney, Tokyo and Frankfurt Branches), KPMG (Singapore), Pacific BMW (Los Angeles), Hong Kong Trade Development Council (Tokyo and Osaka), Hong Kong Economic and Trade Office (Singapore and Tokyo), etc.

實習計劃

恒生大學認為實習是十分有效的學習途徑。同學透過在職訓練及導師悉心指導，學以致用，獲取寶貴的學習經驗。

此外，學生可以參加恒生大學的全球實習計劃，實習地點覆蓋 18 個國家遍及 25 個城市，包括澳洲、德國、愛爾蘭、日本、新西蘭、新加坡、英國、美國等。學生將在公營機構和跨國公司實習，如中國銀行（悉尼，東京和法蘭克福分行）、畢馬威（新加坡）、寶馬太平洋（洛杉磯）、香港貿易發展局（東京和大阪）、香港經濟貿易辦事處（新加坡和東京）等。

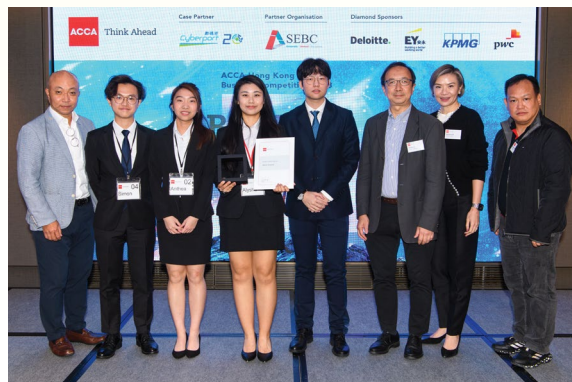


The HKICPA QP Scholarship 2025 and HKICPA Scholarship 2024/25

Q : Are there any admission interviews?

A : Applicants are normally invited for the admission interview. Interviews may offer a chance for applicants to understand more about the profession and the programme.

Q : How does a degree in Professional Accountancy differ from other degrees?

A : BBA-PA nurtures students to become professional accountants. Like the professionals in medicine or architecture, accountants must pass rigorous professional examinations, abide by ethical standards and gain enough practical experience to become qualified. The profession has a clear career path with attractive prospect.

答：BBA-PA 培育學生成為專業會計師。與其他的專業領域例如醫療或建築一樣，會計師必須通過嚴格的考試，遵守道德標準並獲得足夠的實踐經驗，才能取得專業資格。會計專業有清晰明確的事業發展路徑。
